- 3. Work profiles and duties attached with all the Direct Recruitment posts were deliberated upon and all suitable categories of PWDs for each post were discussed. - 4. A review meeting of the Committee of Experts was held on 06<sup>th</sup> September, 2019 at 2:30 pm under the Chairmanship of Director (Finance). The said meeting could not be attended by Shri D K Panda, Under Secretary of DEPD due to his pre-occupation with some urgent work.
- 5. The committee deliberated on the physical requirement and the functional classification of the posts and considered the inputs received from various technical Directorates of DGCA. The Committee has reviewed all the 16 different Direct Recruitment Posts in terms of Section 34 of RPwD ACT, 2016 and has identified the posts suitable for various categories of PWDs as indicated in the table hereunder:
