VACANCY CIRCULAR

Subject:- Filling up of posts of Flight Operations Inspectors in various categories, on contact basis, in the Directorate General of Civil Aviation-regarding.

Applications are invited from Indian Nationals to fill up the following posts, on contract basis, for a period up to 30.06.2020 or till the incumbent(s) attain(s) the **age of 70 years** or till the post(s) is/are filled up on regular basis or until further orders, whichever is earlier:-

- 1) Deputy Chief Flight Operations Inspector (Aeroplane): The total minimum emoluments at the beginning of the pay scale will be Rs. 6,34,852/ (approx.) per month including allowances as are admissible for the post.
- 2) Senior Flight Operations Inspector (Aeroplane): The total minimum emoluments at the beginning of the pay scale will be Rs 5,91,100/- (approx.) per month including allowances as are admissible for the post.
- 3) Flight Operations Inspector (Aeroplane): The total minimum emoluments at the beginning of the pay scale will be Rs 3, 95,626/- (approx.) per month including allowances as are admissible for the post.
- 4) In case of retired/medically unfit candidates for the post of Senior Flight Operations Inspector (Aeroplane), fixed remuneration may be as per the recommendations of the Selection Committee (Rs. 4,40,000/-per month).

- 6) Senior Flight Operations Inspector (Helicopter): The total minimum emoluments at the beginning of the pay scale will be Rs. 2,51,100/-(approx.) per month including allowance as are admissible for the post.
- 7) Flight Operations Inspector (Helicopter): The total minimum emoluments at the beginning of the pay scale will be Rs. 1,95,626/- (approx..) per month including allowance as are admissible for the post.
- 8) The place of duty will be DGCA (Hqrs.) or any other Regional Offices of Directorate General of Civil Aviation (DGCA).

The officers should ensure that the up-to-date photocopies of Annual Performance Appraisal Reports for the

last five years, a certificate from the employer(s) indicating accident free record for last 5 years attributable to his proficiency, alongwith Integrity Certificate, Vigilance Clearance and a statement of major/minor penalty, imposed if any, during preceding last 5 years be sent by the present employer(s), if applicable.

- 3. Self-attested and legible photo-copies of all the relevant documents supporting the candidate's eligibility in terms of the requirements for the respective posts are also required to be forwarded alongwith the filled in application. Applications without the supporting documents will not be considered.
- 4. A Scrutiny Committee would scrutinize the applications. Only those fulfilling the requirements will be shortlisted and called for interview. The selected candidates will be required to join within the time limit prescribed in appointment order, failing which their selection/candidature shall be treated to be cancelled without any further communication and no extension shall be allowed.
- 5. A reserve list for the abovementioned tentative posts will also be drawn up for the period of six months, depending upon the availability of suitable candidates for the respective post(s).
